License Agreement

IMPORTANT READ CAREFULLY:

This Araelium Group End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Araelium Group for the Araelium Group software product "DMG Canvas", which includes "online" or electronic documentation and may include computer software and associated media and printed materials (the "Software"). For "dedicated build machines" using the dmcanvas command line tool, a valid license is needed on each build machine.

- (iii) A purchased license and all of the grants thereof may be permanently transferred to another person or entity, provided the Software has not been used by you, and the recipient agrees to the terms of this EULA. If the Software is an upgrade, any transfer must include all prior versions of the Software from which it was upgraded.
- (iv) You may make copies of the Software solely for backup or archival purposes.

"Preview", "Beta", and other "Pre-release" versions, if available, are provided for a time-limited period for the evaluation and initial product testing use.
